8:30 AM - 12:30 PM : Pre-conference Workshop with Breakfast - Risk Management Cyber Risk: Privacy and Data Security Risk Management

Utilize proactive measures to ensure your organization is protected from cyber fraud and the risks of financial loss, reputational damage and regulatory intervention. This workshop provides tools to implement a compliance plan, ensure data privacy and mitigate damages should a breach occur.

He was Chairman of the Board of the Financial Services Roundtable/BITS Identity Theft Assistance Center (ITAC) and has also served on many national bank industry committees and work groups including BAI, BITS, NACHA, and EFTA.

Keynote Address: The Science of Personality: Another Twist of the Kaleidoscope

Recent research in personality science has shown that personality traits have a major impact on happiness, productivity, stress, health and even mortality. Dr. Brian Little draws on this research and will apply it to our daily lives. He will illustrate how traits explain differences in the need for stimulation in our jobs, the ways we make decisions, the style of communication we adopt and the decisions we make. We are not just the victims of the genetic lottery and our fixed traits. We enact "free traits": nice people who act disagreeably to avert a crisis; neurotic individuals who fake "stability" because the situation demands it; true introverts who act as card-carrying extroverts. Such behavior can be hilarious, poignant and puzzling. But it can also be courageous and this new twist of our kaleidoscopic selves can transform us and our organizations.



Speaker: Dr. Brian Little, Award Winning Psychology Professor

Professor Brian Little has taught with distinction at Oxford, Carleton, McGill, and Harvard Universities and is currently a Distinguished Scholar in the Department of Social and Developmental Psychology at Cambridge University in the UK. His groundbreaking book, **Personal Project Pursuit**, was published in 2007 and has transformed the study of personality and organizations.

Solar Storms: Protecting Against the Sun's 'Dark Side'

Solar storms and resulting "space weather" - high-energy bursts of charged particles and plasma from the sun - can interact with our magnetic field and cause powerful geomagnetic storms with electrical surges. These can disable power grids, transformers and telecommunications. This session will consider the risks of solar storms and explore probabilities being discussed in the scientific community and related industries.

With an overview of labour arbitration highlights over the past year, this session will explore how the Canadian Charter of Rights and Freedoms has impacted the unionized workplace, and developments over workplace health and safety issues. These include random drug and alcohol testing and the repercussions of Bill 168. Discipline issues, including arbitration remedies, will also be discussed. The developing area of privacy rights will be referenced, as well as how higher courts defer to the discretionary powers of labour arbitrators.



The North American economy is still feeling the effects of the recession which ended in 2009. We'll look at what caused the recession, how those factors are affecting the economy now, the government responses, and what the future might hold in this time of unprecedented global economic upheaval.

Dan North has been with Euler Hermes North America since 1996, using macroeconomic and quantitative analyses to help manage Euler's risk portfolio of more than \$150 billion in annual U.S. trade transactions. As an economist he has appeared on CNBC, Fox Business News, France 24, and Bloomberg Radio and Television. In 2010, he was ranked fourth on Bloomberg's list of the top 65 economic forecasters. Dan holds an MBA from the Wharton School of Business.
